Thinking Peace and Humanitarian Protection from a Civilian Perspective Key Messages and Policy Recommendations

The war in Sudan which started on 15 April, 2023, has set off the world's largest humanitarian catastrophe. On 18 September 2025, a broad alliance of humanitarian, development and human rights NGOs, political foundations and think tanks hosted the conference "Sudan – Thinking Peace and Humanitarian Protection from a Civilian Perspective" in Berlin. The event centered on dialogue with Sudanese actors, highlighting the initiatives and resilience of Sudan's active civil society, as well as their expectations of the international community.

Around 230 participants attended, including representatives from the media, the German Federal Ministry for Economic Cooperation and Development (BMZ), the German Federal Foreign Office (GFFO), staff from the German Parliament as well as NGOs and CSOs. Around the conference, bilateral and small-group meetings were also held with high-level policymakers and parliamentarians.

Prior to the conference, two civil society workshops held in Nairobi/Kenya focussed on strengthening convergence among civil society opposed to the war. Among other steps, the actors conducted a mapping of more than 100 organisations, co-designed the second workshop, defined their advocacy messages and selected 10 individuals to represent them on the panels in Berlin.

The key messages below are drawn from the substantive and candid discussions on peace, protection and humanitarian action in Sudan held during the conference.

This war has devastating consequences for the civilian population. Sudanese colleagues made it very clear that they need more international support - both financial and diplomatic - to sustain their humanitarian and peacebuilding efforts. As the conference took place in Germany, the participants directed their messages to the European Union and its member states, including the German government.



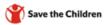
