Alternative Views on Peace and Conflict in Pakistan

Pakistan has become a frontline state in the war on terror both as a result of foreign intervention and due to its own foreign and security policy. Consequently, the country has suffered tremendous losses of human lives and development opportunities especially in the past decade. One part of the problem is that the definition of security for the country so far has mainly been given from a military-strategic point of view. As a result, Pakistan has become increasingly isolated.

This international conference aims at broadening the perspective by focusing on the interface between human and military security, the role of the government and Pakistan's role in the region. How has the existing approach triggered the wave of violence that now threatens the very core of Pakistan? How is it related to the conflicts in its provinces? What are the most urgent needs that have to be addressed in order to secure Pakistan's success as a state and a life in dignity for its citizens? How can it improve its relations with its immediate neighbors and cooperate in the region in order to secure peace and stability? And last but not least: what shall be its future relation with the rest of the world?
